



# PHYSICAL FUSION TRAINING CENTER

## CODE OF CONDUCT:

(Physical Fusion Training Center referenced and abbreviated as PFTC herein)

Parents, members, and program participants must observe the following:

- Respect the rights and privileges of all persons, at all times.
- In case of emergency or disaster, call 911, remain calm, and listen to the guidance of emergency officials.
- Comply with the requests made by staff members, program facilitators, and instructors.
- Refrain from all conduct that may disrupt any program, event, or class. This includes aggressive behavior, rudeness, and obstructive noises.
- Refrain from any lewd, obscene, and indecent conduct or expressions; including profanity, harassment, discrimination, threats, or offensive remarks.
- Refrain from any action that attempts to inflict injury or directly inflicts injury to another individual. Staff members have absolute authority in determining if an action is threatening or dangerous.
- Children who are not participating in a scheduled program, event, or class must be accompanied by a non-participating, supervising, and responsible adult.
- Damage, destruction, and theft of property belonging to another person or to PFTC itself is unacceptable. Any lost items found at the facility should be left alone, or may be placed in the lost-and-found by a staff member.
- Smoking is not permitted anywhere inside, or outside within 20 feet of the facility.
- Possession and use of weaponry or explosive devices is not allowed.
- Distribution, possession, and use of illegal drugs or alcohol is not allowed.

## ENFORCEMENT:

Failure to comply with any of the rules above may result in immediate suspension or expulsion from the facility without perpetuation or refund of membership privileges and fees.

## LEASE, WAIVER, AND CONSENT:

By enrolling at Physical Fusion Training Center, the participant and his/her parents (or legal guardians) understand that he/she is attending the programs, events, and classes at PFTC, using the facility, equipment, and collective premises at his/her own risk. PFTC, its owners, employees, agents, contractors, affiliates, subsidiaries, successors, and assigns (the "PFTC Parties") are not liable for any damage, personal injury, or property loss sustained to the participant or his/her family resulting from the participant's actions or from negligence by the PFTC Parties. The participant and his/her parents (or legal guardians) assume full responsibility for all injuries and damages that occur in or are related to the programs, events, and classes at PFTC and its premises. Participants and their parents (or legal guardians) do hereby fully and forever release, discharge, and hold harmless the PFTC Parties against all claims, demands, damages, or rights of action, present and future resulting directly or indirectly from participating in the programs, events, and classes at PFTC and its premises. Additionally, all photos, videos, and media created by PFTC (which may include the participant or his/her family) are exclusive property of PFTC and may be used without restriction on any of PFTC's marketing channels (e.g. - websites, social media, etc.).
